### Review of July 11, 2012 Agenda:

John Salazar, County Manager; Tisha Green, Assistant County Manager; Chairperson Chaires, Commissioner Kerr and Commissioner Shannon reviewed and discussed the upcoming agenda items. No action was taken.

#### **Desert Mountain Corp. Presentation/Randy Quick:**

#### County Road Issues/Levi Klump:

# Resolution 2012-30/CCI Participation:

In this resolution, the SWNM Council of Governments will represent Hidalgo County and Catron County by applying for the CCI (Certified Communities Initiative) Program to help with economic development.

#### **Resolution 2012-31/COG Fee Agreement:**

This resolution and agreement are renewed annually for the services provided by SWNMCOG to the County as members of SWNMCOG.

#### Resolution 2012-32, Resolution 2012-33, and Resolution 2012-34/Roads:

These resolutions are in regards to match waiver requests for the CAP (County Arterial Project) and the COOP (Cooperative Project) and the acceptance of the School Bus Route Project.

#### **Consideration of County Infrastructure GRT Ordinance:**

In order for a local option tax to be implemented, the question must go before the people on the general ballot. Only the unincorporated areas in the County will be affected.

## Gila-San Francisco Water Commission Request for Board Representation:

The Gila-San Francisco Water Commission is requesting that the Board appoint representatives from the County to serve on the Water Commission. They need one voting member and one alternate voting member.

### **Dispatch RFP:**

The County Manager is requesting permission to advertise with the Las Cruces Sun News for the construction and design of the dispatch center. The dispatch center must meet broadband federal requirements by 2013. No bids were received when they advertised locally.

#### **Safety Award:**

The County received a safety award from the New Mexico Association of Counties for having the lowest workers' comp claims in the state.
